

INTRODUCTORY WORD



The first wave of lockdown in spring of 2020 was used to create professional methodologies for working with the client, which can be used both through in-person contact and through the online space. The methodologies are part of the online tool SOCIO, which we are gradually developing as a unique project in the social field with the help of fellow consultants. SOCIO was also ordered by other key players in the area of Social and Legal Protection of Children and Social Guardianship (further SPODaSK) the non-profit organizations "Úsmev ako dar", "Návrat", "Alternativa" and others. Through data collection at SOCIO, we strive to set better and more effective public policy in the area of parental conflicts, field work in poor families.

In 2020, we received an offer from the management of the Association of Supervisors and Social Counselors (ASSP) to take over the organization. We agreed that we care about maintaining the sovereignty of this

organisation and we started working on the development of education and expertise in the social field using a highly professional and broad membership base. This brought us further opportunities for development, especially in the field of expert education. We want to be able to transform our expertise into systemic changes in the social field.

The year 2020 was hit by the COVID-19 pandemic and it was a difficult and groundbreaking year not only for the world, but also for us at TENENET. For the performance of our professional work, this unexpected situation had an extraordinary impact and changed the whole reality of the past. We started to implement more measures and services in the online space. In cooperation with colleagues in the field, we solved technical support for clients. We helped children in poor families with sponsorship gifts in the form of laptops and tablets. Through data cards from Slovak Telekom, we helped them connect to the Internet and manage online school teaching.

The year 2020 also brought the expansion of our counseling centers throughout Slovakia. We cooperated with thirty district labor offices and our field consultants provided services in all regions of Slovakia. Compared to 2019, when the organization had 35 employees, by the end of 2020 it already had 55 employees, which caused great dynamic growth in the personnel area. After careful consideration, we came to the decision to acquire our own building as the new headquarters of our organization. At the end of the year, we moved to a new, 4-story building on Oravská 4, in Senec. We have created a spacious meeting room for 60 people, 3 separate outpatient counseling centers for families with children in rehabilitation and parental conflicts, we have opened new counseling centers and also set up clinics of psychology and psychotherapy, which have their own quiet rooms for individual counseling.




We believe that the year 2021 will be a good year for our further activities and projects, in which we will try to improve the quality of life for all who need it.

HISTORY OF NON-GOVERNMENTAL ORGANIZATION TENENET

TENENET was established in Senec in the year 2011 as a response first to the needs of disabled people, families with children with disabilities, but also the long-term unemployed with an interest in helping to find a job in our sheltered workshop WELLNEA as an example of good practice. Thanks to our support program and significant discounts for poor people in WELLNEA, women from socially disadvantaged families in particular have started to turn to us and ask us for professional help.



In the summer of 2013, it expanded its activities to persons at risk of social exclusion thanks to the obtained accreditation SPODaSK (305/2005 Coll.), Specialized social counseling and (448/2008 Coll.), Agency of supported employment (5/2004 Coll.) and subsequent registration and registration at BSK s outpatient performance in the counseling center in Senec and in the field in TTSK. In 2015, we expanded our social services within the Community Center and Early intervention services, which we operate in the Jánovce Community Center, Galanta District on an <u>outpatient and field basis</u> for the entire Trnava region, and since 2016 the Community Center in Senec (field for the Bratislava region).

We operate in 2 <u>outpatient</u> facilities - the Community Center KC Senec (district Senec and Pezinok) and the Community Center KC Jánovce (district Galanta) with field performance in the Bratislava and Trnava regions.



<u>Projects versus organizational</u> <u>development from 2017 to 2020</u>

Staffing was significantly strengthened thanks to the acquisition of 4 demand-oriented projects in 2017 focused on the implementation of measures of social and legal protection of children and youth and social guardianship, designed mainly for the salaries of new professionals. And also in 2019, thanks to the accreditation of the Center for Children and Families (§45 of Act 305/2005 Coll. On SPODaSK), we obtained a pilot project of the Central Office of Labour, Social Affairs and Family priorities of the 2019 headquarters according to the amendment. The organization employed 54 full-time employees (part-time or full-time) in year 2020. Specifically, the composition is 7 management and 47 professionals, namely 25 social workers; 15 psychologists and psychotherapists and 3 special pedagogues, 2 social pedagogues, 2 speech therapists.

Together, in 2020, we provided our services to 3106 clients (approximately 1,035 families) from all over Slovakia (all regions).

As part of the services of 2 community centers, we provided our social crisis intervention services at the community level to a total of 433 clients in both CCs (CC Senec 303 clients, CC Jánovce 130 clients). Through specialized social counseling, we addressed 174 clients, and through early intervention services, we addressed 246 children with disabilities.

Through the implementation of SPODaSK (Social and Legal Protection of Children and Social Guardianship) measures, we provided our services to a total of 2,253 clients (of which 1,493 new this year) clients from disadvantaged backgrounds from poor families in material need, integrated in primary school due to learning or behavioral problems, disabled children and young people, former abused children and young people sent to us by social curators from the Central Office of Labour, Social Affairs and Family or from schools, educational counselors, etc.). Through the priorities of the headquarters (ie distributed from SPODaSK department or court decisions), we provided services to 498 children from 246 families from all over Slovakia. With a focus on Supporting the implementation of measures of social protection of children and social guardianship in an open environment and streamlining the resocialization of drug and other addictions - since the beginning of the project in 2017 we have a total of 376 clients, ie in 2020 55 new clients. Support for the implementation of measures of social protection of children and social guardianship in the natural family environment - since the beginning of the project in 2017 we have a total of 568 clients, so in 2020 new 129 clients were added. We addressed 313 clients through the implementation of SPODaSK measures as voluntary clients recommended by local governments.



CENTER FOR CHILDREN **ND FAMILIES**

THE YEAR 2020 WAS THE MOST DYNAMIC YEAR IN THE HISTORY OF THE TENENET ORGANIZATION IN THE AREA OF SUPPORT FOR THE IMPLEMENTATION OF MEASURES OF SOCIAL AND LEGAL PROTECTION OF CHILDREN AND SOCIAL GUARDIANSHIP (SPODASK). WE HAVE BECOME THE LARGEST NON-STATE CENTER FOR CHILDREN AND FAMILY (CDR) WITH FIELD AND OUTPATIENT PERFORMANCE WITH NATIONWIDE COVERAGE.

In 2019, thanks to the accreditation of the Center for Children and Families, we obtained a pilot project of the Centre for Labour, Social Affairs and Family priorities of the 2019 headquarters according to the amendment, which allowed us to strengthen staffing of this agenda.



In addition to the "Priorities" project, we also worked on projects aimed at supporting the implementation of measures for the social protection of children and social guardianship in an open environment and streamlining the resocialization of drug and other addictions, to support the implementation of measures of social legal protection of children and social guardianship in the natural family environment and we also worked with voluntary clients recommended by local governments.



We help families overcome divorce / separation periods, we solve children's educational problems, rehabilitation and neglect of children. surrogate family systems, CAN syndrome (abused and mistreated children).

IMPORTANT FACTS

- through the implementation of SPODaSK measures, we provided our services to a total of 2,253 clients
- through priorities of the headquarters (ie distributed from SPODaSK department or court decisions) we provided services to 498 children from 246 families
- we cooperated with 30 Offices of Labor, Social Affairs and Family throughout Slovakia

<u>Important information</u>

We try to be as close to the client as possible: in addition to Senec, we operate in 12 outposts "Tenenet Center for children and family" throughout Slovakia - in Pezinok, Hlohovec, Trnava, Galanta, Nové Zámky, Rimavská Sobota, Veľký Krtíš, Trenčín, Námestovo, Stará Ľubovňa, Svite and Michalovce, where our regional colleagues provide SPODaSK services directly in the field.



90% of our working time consists of field trips - directly to the family or open (especially schools and municipal / city offices) environment of clients. We provide outpatient social diagnostics as well as psychodiagnostics and professional psychological counseling, which is performed by certified psychotherapists, social workers, psychologists, special pedagogues, social pedagogues and speech therapists.

We provide diagnostics, counseling and group training. We address parental conflicts, educational problems, neglect and poverty, foster families, child and youth abuse.

COMMUNITY SUPPORT

In 2015, we expanded our social services with the Community Center and Early Intervention Services, which we operate in the Jánovce Community Center, Galanta District on an outpatient and field basis for the entire Trnava region.

Since 2016, the Community Center in Senec (field for the Bratislava region) has also been serving as an outpatient clinic.

Through our community centers, we have provided and offered services to individuals as well as families and the local community. We helped socially weaker clients and those who found themselves in an unfavorable life situation.

We created opportunities for meaningful leisure time for and we also organized preventive activities against the spread of the COVID 19 pandemic.



WE COOPERATED WITH:

- with the Bratislava Archdiocesan Charity material and food aid
- with TESCO Senec we participated in the food collection, 3 times a week we have the opportunity to take various goods from TESCO (bakery products, snacks, fruits and vegetables), which we pack and hand over to clients
- with LYRECO regular food support
- with the Kysucká Private School in Senec
- with the kindergarten in Jánovce in securing cultural events
- with Homes for social services and Homes for the elderly















Important information

During 2020, we implemented activities aimed at:

- meaningful leisure time for children: children's summer camps for children from socially weaker families in Senec and Jánovce, summer cinemas for children
- group activities for pensioners: nordic walking, memory training, work training for seniors
- group activities for mothers on maternity leave on a weekly basis education support: group and individual tutoring of Slovak and English language, mathematics
- assistance in applying on the labor market requirements of job opportunities for clients and job placement in cooperation with companies in the region community activities, mediation of material and food aid: we organized "Burzy bez peňazí" seasonal exchanges of clothes, school supplies and aids, food. We redistribute kilograms of durable food and implement the "Pošli tašku" project, through which volunteers made purchases of food and medicine for our lonely living seniors, for homeless citizens, for clients with disabilities.
- Preventive activities prevention against COVID 19, in primary schools dedicated to addiction prevention
- The "Dobro v človeku" campaign, which aimed to support families before Christmas who are facing an unfavorable life situation.

IMPORTANT FACTS

- as part of the services of 2 community centers, we provided our social crisis intervention services at the community level to a total of 433 clients in both CCs (CC Senec 303 clients, CC Jánovce 130 clients)
- through specialized social counseling, we took care of 174 clients
- As part of the "Good in Man" campaign, we managed to donate to more than 150 families from all over Slovakia



SPEECH THERAPY AND SPECIALPEDAGOGICAL ADVICE

In 2020, we established a non-governmental private special-pedagogical and speech therapy clinic. We also started to provide services within the special-pedagogical and speech therapy counseling center.





In the area of special pedagogical counseling, we focused on early care and care for children in preschool and school age.

We offered speech therapy diagnostics and therapy in the speech therapy clinic. The diagnostics showed us at which language levels it was necessary to strengthen our intervention in therapy, we focused mainly on early intervention, which is important in the field of speech development, in order to prevent impaired communication skills.

IMPORTANT FACT

Through our services, we focused on 246 children with disabilities.



AMBULANCE OF CLINICAL PSYCHOTHERAPY

An important milestone was the year 2019, when we expanded our services in the field of social affairs with medical services, specifically we became a non-state medical outpatient clinic of clinical psychology and psychotherapy.

During 2020, we offered our clients the following services:

- individual, group, couple and family psychotherapy
- psychodiagnostics focused on work and health purposes



EMPLOYMENT SUPPORT

We provided consultations for natural and legal persons on the establishment of a sheltered workshop or on the registration of social enterprises.

We helped recruit suitable employees from disadvantaged and vulnerable backgrounds and integrate them into the work process.

9. we participate in expert conferences dealing with civil society, in particular the contribution of the non-profit sector to solving EU social problems, organized by the European Economic and Social Committee as the main advisory body of the EU (expert advice to the European Commission, EU Council and EU Parliament through opinions on proposed EU legislation) and own-initiative opinions on issues to be addressed creates a bridge between the EU institutions and organized civil society) - they involve us in a structured dialogue.
